The station produced an exceptionally moving and well-prepared segment on the Memorial Wreath Ceremony conducted by the Southeast Region Chaplain in July at the site of the Skyway Bridge disaster. The station airs Civil Air Patrol spot announcements on a routine basis and has maintained a continuing rapport with the Wing.

Reporter Stephen Gauvain, who covered the wreath ceremony together with cameraman Les Rose, accepted the certificate on behalf of the station.

Florida Wing Staff Receives "Excellent" Rating In Southeast Region Evaluation

Florida Wing's staff operations received a preliminary overall "excellent" rating from the Region Evaluation Team led by COL James Shattuck, SERLO, on 17 January. COL Shattuck complimented the Wing Staff on its effort. Adding his personal congratulations was COL L. H. McCormack, SER Commander, who was present at the Evaluation Team's outbriefing.

Outstanding Rating

Senior Training was recognized as outstanding on the basis of the good planning and documentation and the impressive training program being developed by LT COL James Mowbray, who was commended by COL Shattuck for his work.

Emergency Services received an outstanding rating as a result of the air and ground operations being conducted and for the procedure of reissuing "101" cards on an annual basis.

Excellent Rating

Cadet Programs was rated excellent with favorable comment made on record maintenance. The wide range of cadet activities developed within the Wing by LT COL Thomas C. Welch and his staff was commended.

Both the Chaplaincy and Communications were rated excellent and received favorable comment on record maintenance. The Communications records were viewed as outstanding

Public Affairs was rated excellent, and Captain William G. Warner was recognized as doing excellent work and providing good training at subordinate levels.

Safety received an excellent rating with specific comment that directives regarding use of special purpose vehicles were impressive.

Satisfactory Rating

Aerospace Education received a satisfactory rating. MAJ Paul Foster, Director of Aerospace Education - External, was recognized for his excellent support of the Aerospace Education Congress in 1980, and Captain Ray S. Taylor, Director of Aerospace Education - Internal received favorable comment on his plan of action in the area of internal aerospace education.

Finance, Plans and Programs, and Personnel received satisfactory ratings, as did Operations.

Logistics, Transportation, and Supply were rated satisfactory. Supply control at Wing Headquarters was cited as excellent.

Marginal Rating

Administration received a marginal rating due to lack of records and Transportation Authorizations for 1980. Captain George Metz, Director of Administration, however, was complimented for the very obvious effort being made to meet administrative standards and the excellent job he has done since accepting the position.

Despite evidence of good data, inspection was rated marginal because of lack of documentation below Group level.

Response to the initial Squadron Staff School indicates it fills a definite need for staff assignment training, according to LTC Mowbray. Additional Squadron Staff Schools have already been scheduled, and details will be published in the Senior Training Bulletin as arrangements are finalized.


Ocala Composite to support FAA pilot upgrade program

Ocala Composite Squadron announced that the unit will sponsor the "Pilot Proficiency Program" developed by the FAA, Southeastern Region to upgrade air pilots. Mr. Robert J. MacDonald of Venture Aloft in Ocala will direct the program.

The first phase, which began in December, will consist of 120 days of upgrade training including classroom instruction, films, and actual inflight performance. All aircraft — single and double engine, helicopters, and balloons — are included. Graduates will be awarded designated wings at completion of each of the three increasingly complex phases that make up the program.

From the Editor's desk

Last April I had the pleasure of serving on the Senior Staff at the first Florida Wing Cadet Command and Staff School at MacDill AFB. The purpose of the CCSS was to introduce management concepts to the Senior Cadet Officers of Florida Wing using members of the Suncoast Chapter of the American Society for Training and Development as instructors. I know I personally benefitted from sitting in on the training sessions, and, being a Cadet Squadron commander at the time, I also saw the effects of that training showing up in the planning being done by cadet officers from my unit who had attended.

One of the training activities was the preparation of a speech on the subject, "The Role of the Senior Cadet Officer", to be presented before a panel composed of Air Force officers and a Reserve NCO, all of whom had worked with the cadets during the CCSS. Each speech was evaluated and critiqued by the panel on the basis of content and presentation. Each speech was distinctive, both in content and presentation; all were im-

WING STAFF BULLETINS



Safety Corner

FACT: Night vision deteriorates rapidly above 5,000 feet. Your landings and takeoffs will be sharper and night flying much safer if supplemental oxygen is used at night from the ground up.





FACT: Approximately one-third of General Aviation fatalities could be prevented by the wearing of shoulder harnesses and seat belts.

FACT: Your medical certificate is legally invalid during any period of illness that prevents you from performing your flying duties properly.





FACT: If you fly 6 to 8 hours weekly without ear plugs or other protection, you can experience some degree of permanent hearing loss within a few years.

Personnel Promotions

The Wing Personnel Section is experiencing difficulty in processing many promotion requests because of incomplete paperwork.

Promotion is a privilege to be earned, and there are many requirements that must be met other than time in grade. The unit commander requesting promotion must insure that completion of these requirements is properly documented. Promotion to 2/LT requires completion of Level I Orientation; all other grades require certain Level II requirements to be met; Major requires completion of ECI 7C and assignment to a job calling for the rank; Mission and Special promotion requests require submittal of copies of all paperwork verifying professional qualifications. Much of the above is included on the Quarterly Senior Training Roster; the unit commander should check the Training Roster to ascertain that the information is shown. If not, and in many cases the units are not properly updating the Training Roster, the unit commander must verify that the requirements have been met and submit copies of any necessary paperwork to

In other cases, promotion requests are being submitted without Group approval. Be sure to follow the proper chain of command in submitting promotion requests.

Unnecessary delays are again often caused by failure to submit four copies to Wing.

Attention to these items will insure that the promotion earned is promptly granted.

Uniforms

Officers must project the best possible image of Civil Air Patrol. Promotion to grades requiring appearance before a Promotion Board will certainly be affected by uniform discrepancies or sloppy uniforms. Jumpsuits are not acceptable for appearance before the Wing Promotion Board.

Some of the most common uniform discrepancies are listed below:

1. Ribbons Not Worn on Service Uniform Coat

Ribbons are mandatory on the service uniform coat and pantsuit jacket (male uniform Combination 1; female uniform Combination A and C; and male and female semiformal uniform).

2. Ribbons Worn Upside Down Examples: Membership Award (Senior); Grover Loening Aerospace Award.

3. Blue Plastic Three-Line Nameplate Worn on Service Uniform Coat

The blue plastic three-line nameplate is not authorized on the service coat (male or female) or the female pantsuit uniform coat. The black plastic nameplate and metal identification badge are still required.

- 4. CAP Cutouts on Coat Lapels Not Worn Parallel to the Ground
- 5. Wing Patch Worn More Than 1/2 Inch From Shoulder Seam on Left Sleeve

6. Officer Sleeve Braid Not Worn on Female Pantsuit Uniform

While no sleeve braid is worn on the female service uniform coat, it is required on the pantsuit uniform coat 2-1/2 inches from the end of the sleeve.

7. Specialty Insignia Not Centered Above Ribbons

Specialty insignia is centered ¼ inch above ribbons or ½ inch above left breast pocket (if ribbons are not worn) and ½ inch below wings, if authorized. Exception: Chaplain specialty insignia is worn ½ inch above wings, if authorized.

8. Outdated "Droopy" Wings Worn Instead of New "Straight" Wings

9. Regular Size Grade Insignia Worn on Shirts

Miniature grade insignia is worn on shirts; regular size is worn on uniform coats.

10. Incorrect Insignia Worn on Epaulet Shirt

Senior members with rank wear epaulet "sleeves" carrying both CAP and grade insignia; no collar grade or CAP insignia is worn. (This applies to cadet officers also.) Senior members without rank (S/M's) wear no epaulet "sleeves", but rather wear CAP cutouts on both collars of the epaulet shirt. (Cadet airmen/NCO's wear grade insignia on the right collar of the epaulet shirt and CAP cutouts on the left collar.)

Senior Training Level I

The Level I orientation course is the first step the new senior member takes in a Senior Training Program that is essential within Civil Air Patrol and which can be of great benefit in his or her everyday employment. The course usually runs from 0900 HRS to 1600 HRS and concludes with a 70-question review/exam, corrected to 100%. The exam is retained by the students as a review tool. Only instructors certified by the Florida Wing Director of Training may teach this course; and to make it as widely available as possible, the Wing has been divided into five Training Areas under the direction of Chief Circuit Riders with the responsibility for supervision of Level I instructors, quality assurance, and reporting.

Any Group or Squadron commander or training officer may arrange for a Level I by contacting the appropriate Chief Circuit Rider. **ECI, ETC.**

During the Level I program, the student will be introduced to the wide

variety of training opportunities available within Civil Air Patrol. The ECI program offers a broad range of management and vocational correspondence courses to CAP members. The Florida Wing Squadron Staff School provides basic training in specific Group/Squadron duty assignments. Squadron Leadership School offers an overview of unit operations and leadership techniques to the unit command and staff officers. Staff Colleges are available at both Region and National level. A highly-trained and professional SAR Staff School, Aircrew Training Program, Mission Coordinator initial and update training, and SAR schools at Region and National levels. The Civil Air Patrol training program offers members an opportunity for professional training of benefit both in and outside of the organization, as well as an opportunity to meet their fellow volunteers from across the nation and exchange ideas. Take advantage of these opportunities.

Minutes Cadet Advisory Council Meeting

18 October 1980 — Florida Wing Commander's Call Gainesville, Florida

The meeting was called to order at 1330 by the Chairman, C/LTC Paul A. Griffith, Jr.

The Pledge of Allegiance was led by C/LTC William H. Cumler, Wing CAC Vice-Chairman.

The minutes of the last meeting of the CAC, 30 March 1980, were read and passed unanimously as read.

C/LTC Griffith stated the ground rules for the CAC meeting.

C/LTC Cumler discussed the actions from the last SER CAC meeting, 25 July 1980. There was a brief discussion on the uniform section of the SER CAC minutes.

C/LTC Griffith explained the new SOP for FL WG CAC. After a discussion about certain technical points of the SOP, the SOP was passed unanimously, with the condition that a committee be set up to amend the SOP when conditions necessitate such amendments.

The committee is chaired by C/LTC Cumler and is composed of C/LTC Matt Maranto - Sector B Coordinator, C/MAJ Robert Mattie - Group 16 Chairman, C/WO Marty Nichols -Group 3 Chairman, C/WO Alan Williams - Group 6 Vice Chairman, and C/MSgt Danny Vukmanich -Group 9 Chairman.

The floor was then opened to old

- 1. Fraternization was briefly discussed until C/LTC Griffith explained that the new policy is before the SER
- 2. Uniform items, such as black berets, ribbons, and uniforms, were discussed. This discussion was closed after C/LTC Cumler explained that all these items of argument are before the SER CAC or in CAPM 39-1.
- 3. Boot blousing was discussed, but the present Wing directive stands.

The floor was closed to discussion on old business and opened for discussion on new business.

1. C/LTC Griffith read a letter from COL Leali which stated that cadets of the New Modified Cadet Program are allowed to wear the jumpsuit to all National activities, except Drill Competition (above Wing).

2. C/LTC Griffith discussed the possibilities of the Wing possibly having CCSS's (Cadet Command and Staff School) for Phases II and III, as well as the present Phase IV CCSS.

A break was then taken at 1500, and the meeting reconvened at 1515 in Room 319.

- 3. A discussion of Senior-Cadet relations was tabled until later on in the meeting.
- 4. C/MAJ Thomas Kaczmarek, Group 17, proposed a C/NCO Leadership School. After a discussion it was decided to table the discussion until after a working program was presented to the Wing CAC.
- 5. 1/LT Larry Anderson, Senior Advisor to the Wing CAC, talked about a new program of cross chartering CAP Cadet Squadrons with Scout Explorer Posts. The program was endorsed by the Wing CAC. More information may be requested from LT Anderson through LTC Thomas Welch.
- 6. LTC William Breeze, SER DCP, discussed the SER CAC and SER proposal to move the National CAC meeting from the National Board Meeting to COS at Maxwell AFB. This was endorsed by the Wing CAC.
- 7. There was a discussion of the SER CAC proposal to grant the power of promotion and demotion of cadets by the Squadron Commander with the approval of the Wing DCP. The proposal was amended by the Wing CAC to read, "only the demotion of cadets should be allowed". This amended version passed unanimously.
- 8. A proposal to have Senior Cadet Officer and C/NCO instructors at the cadet portion of the Level I passed unanimously.

The floor was then closed to discussion on new business.

C/LTC Griffith then discussed Senior-Cadet relations. He stated that cadets needed to respect all senior members regardless of their own personal opinions. He added that it was up to the cadets to start this change in relations.

The floor was then opened to Group Chairman's reports.

After a final Wing CAC rebuttal, the Wing CAC staff made their reports. C/LTC McLaughlin emphasized the need for all Groups to send in their CAPF 2a's and meeting minutes.

C/LTC Griffith and C/LTC Cumler then briefly summarized the

The Outstanding Senior Cadet Officer


Why does he stand out in a crowd? What are the distinguishing characteristics that separate him from all other cadet officers? This type of leader meets responsibility. Meeting responsibility takes determination, dedication, and hard work. It takes will and effort. It takes vision and boldness that can only be brought about my mastering what I believe to be the two major factors that are indicative of the outstanding senior cadet officer — attitude and self-discipline.

Attitude is the state of mind in approaching every aspect of life. Attitudes are contagious. They slowly affect the actions of others. The cadet officer who displays a positive attitude provides the cement which bonds his or her unit into a workable force. He also promotes cooperation and esprit de corps. The senior cadet officer is looked upon by the basic cadet and the junior cadet officer as a guiding force in the cadet program, and it may be this senior cadet officer's proper attitude alone that provides the incentive for subordinate cadets to remain in the program. The inverse of this situation is the officer with poor attitude. This attitude may result in low morale and a breakdown in unit effectiveness. Proper attitude does not come overnight. It must be developed developed by hard work and selfdiscipline, which is my next point.

If I had to pick one single word that compliments the outstanding senior cadet officer the most, it would be self-discipline. It is the absolute nucleus about which the effective leader and officer is centered. Once self-discipline is developed, all other leadership traits — such as proper military bearing, setting the example, integrity, professional competence, self-confidence, a sense of responsibility — all of these easily fall into place.

Self-discipline, like a proper attitude, must be developed. It may

mean many hours of sacrifice on the cadet's part, sometimes making the cadet want to give up. But remember, the cadet who does not give up can move mountains. I would like to challenge every cadet tonight to strive for this high degree of determination. The senior cadet officer is charged with maintaining and strengthening those academic, moral, and leadership characteristics that help to develop dynamic Americans and aerospace leaders. Your personal challenge is to stimulate other Civil Air Patrol cadets with a strong desire to excel in this challenging and rewarding program which offers leadership training unequaled anywhere in our nation for our age group.

The qualities of a senior cadet officer are best summed up in the familiar words of one of our greatest military leaders, **General Douglas MacArthur**, "Duty, honor, country—those three hallowed words reverently dictate what you ought to be, what you can be, what you will be. They are your rallying points: to build courage when courage seems to fail; to regain faith when there seems to be little cause for faith; to create hope when hope becomes forlorn."

Aerospace Education

Results of Florida Wing Aerospace Education Resource Questionnaire

In October 1980, a questionnaire was distributed with the Aerospace Education Bulletin. The purpose was to give me an overview of the state of internal aerospace education in Florida Wing and to serve as a basis of action to improve this important program. While the results have been valuable in terms of the depth of thought on the part of the respondents, they have been disappointing in terms of quantity. Thusfar, I have heard from approximately 15% of the units in Florida Wing - not a very good statistical basis for action. I would like to sincerely thank those individuals who took the time to consider their internal aerospace education program and respond.

Following is a summary of the results of the questionnaires returned. I will discuss the responses first, then editorialize some on my thoughts as a

result

The first section addressed the availability of personnel to conduct an aerospace program within the units. Thirteen of the seventeen responding units indicated that an Aerospace Education Officer was assigned; the other four said that someone was acting in this capacity. About half were pilot and/or teacher qualified; very few were members of aerospace associations. More than half of the units use senior cadets to instruct aerospace classes, although the reviews on the success of this approach were mixed. About half indicated the part-time use of non-CAP individuals as instructors.

The second section of the questionnaire addressed the content of the aerospace education program. Almost all units had classes, ranging in frequency from one per meeting to three per year. Orientation flights were not conducted as frequently as the classes. with about half of the units reporting flights from twice per year to once per year. Labs and tours were also used by most units with frequencies ranging from once a month to once a year. In the "other" category of activities, glider orientation flights, hot air balloons, and model rocket and aircraft contests were mentioned. All

units indicated that they prescheduled their aerospace education activities, although the lead time varied considerably. All units indicated on-going or periodic use of the training aids listed. Predominant was the sectional aeronautical chart. Many listed additional literature, over and above Your Aerospace World, which they use in support of their programs. (I'll make this list available in a future Aerospace Education Bulletin.)

The next section questioned the frequency and logistics for orientation flights. Eight units reported that they used pilots within the unit for this support; a higher number reported that pilots were obtained from a different unit. About half of the units indicated that they used Corporate aircraft in support of their program while the others used privately-owned equipment or a combination. With respect to orientation flight goals, not all units reported. Of those that did, a higher percentage met their 1979 goals than those for 1980. Two units reported that they had had no orientation flights at all and that this constituted a serious problem in their aerospace programs. Two units reported that their cadets helped to fund the orientation flights through working in exchange for the rides. Types of work mentioned were hangar painting and aircraft washing. This may be food for thought for those units wondering how they might pay for this important program.

The questionnaire next addressed the use of non-CAP resources to support the unit Aerospace Education effort. A number of reporting squadrons indicated that periodic use was made of these resources, with general aviation, USAF, FAA, flying clubs, ROTC, and Air Force Association assistance mentioned. In addition to direct involvement in the program, these resources were also mentioned as "latch keys" to resources which otherwise would have been unavailable; for instance, tours.

I intend to discuss the various sections of the questionnaire in greater detail in upcoming issues of the Aerospace Bulletin. I have, however, drawn some conclusions from the overall exercise; the information submitted, and the lack of it. I've concluded that the greatest impediment to im-

proving the Aerospace Education Program for Florida Wing is the lack of people to address the issue, full time. Aerospace is a subject which cannot be "left-handed". Without motivated individuals to prepare lessons, teach, counsel, and coordinate resources, we won't be able to do much more than limp along. I'm inclined to think that those questionnaires which were returned were done so because of the interest and involvement of the responders and, conversely, that I didn't hear from the majority of the units because of the lack of these people. One of my first priorities for 1981, therefore, will be the emphasizing of the need to recruit and train Aerospace Education Officers for both Groups and Squadrons.

Aerospace Education, like most activities with which CAP is involved, cannot be improved by one person; it must obviously be a team effort. My feeling is that the Groups are key in furthering this due to their ability to work with and influence the units under them most directly. I think that the Group Aerospace Education Officer position is thus vital to our collective efforts toward improvement. Those Groups which do not have assigned AEO's should make every effort to recruit and fill this position. We will then be in a much better position


